#### PROCEDURE FOR EDUCATING YOUR CHILD AT HOME

#### Dear Parent:

The District has established the following requirements and limitations to home education:

#### Participation in School

Students who are excused from attendance at school by reason of home education, in accordance with the rules of the State Board of Education, will be deemed to have withdrawn from enrollment in this District during the period of home education. Therefore, your child will not be eligible to participate in any of the student services, programs, or activities of the District including, but not limited to:

- [] attendance at a District school on a part-time basis;
- [] participation in school-sponsored athletic programs or teams; (Ohio High School Athletic Association eligibility rules require that students must attend the school in which they are enrolled before the can participate.)
- [] participation in school-sponsored, co-curricular or extra-curricular activities or programs.

#### Assessment

You must submit to the Superintendent, at the end of each school year or upon completion of any course of study taught at home, the assessment used and the performance results of your child that confirm s/he has mastered the content of the course. This assessment should include:

- a portfolio of work done;
- [] examples of tests and test scores;
- [] resources and books used in the course;
- standardized test scores demonstrating the student's ability;
- [] course of study completed;
- [] the number of hours devoted to each course of study.

Your child will be permitted to take achievement/ability tests normally given at each grade by the District. This will be done cost-free but must be done during the regular testing cycle. It is your responsibility to make the appropriate arrangements with the School principal. The District will not pay for any standardized testing of students not enrolled in this School District. Your child may take tests such as the PSAT, PLAN, etc. normally given at the high school at the same cost charged high school students.

#### Re-Enrollment in Public School

If you wish to have your child return to a school in this District, you must follow normal enrollment guidelines. The following conditions will apply to determine the appropriate grade placement which will be made by the school principal and appropriate staff:

[] Placement will be based upon:

#### Kindergarten through Grade 8:

- () the child's most recent annual academic assessment report that has been submitted to the Superintendent;
- () age and readiness to participate properly in the grade level program.

#### Grades 9 through 12:

- () to enter the high school in your resident district, you must provide an academic assessment report for each class taken as submitted to the Superintendent. In addition, the school will need the grades from the last public or private school attended.
- () four (4) weeks advance notice is needed to review the assessment report to make proper grade and subject placement.
- () placement into a grade (e.g. 10th) and subject (e.g. English) will be made according to 1) age appropriateness; 2) the results of the review of the academic assessment report provided by the parent to the County Superintendent; and, 3) other evaluation information as deemed necessary by the District (may include interviews with child and/or parent(s)). A home-schooling review team made up of the principal, head counselor, and/or others selected by the Superintendent.
- () athletic eligibility will be determined by OHSAA guidelines and the District's athletic policy.
- [] Students can only enroll at the beginning of each semester.
- [] All home-based, private education courses will be given a grade of P/F (Pass/Fail) and transcripts will denote "home-education, private education" with "P/F grades" and "credits" assigned.
- [] Your child's grade-point average will be established after s/he has completed \_\_\_\_\_ consecutive semesters of attendance at the high school. To be eligible for awards such as Valedictorian or Salutatorian, Distinguished Scholar, Ohio Academic Scholarship, etc., your child must be enrolled for \_\_\_\_\_ consecutive semesters prior to the second semester of the senior year.
- [] If your child wishes to graduate from the District high school, s/he must pass the 9th grade proficiency test and meet the requirements as specified in Board policy and graduation guidelines.

## Defiance City School District Administrative Guidelines

#### 9270 - PROCEDURE FOR EDUCATING A CHILD AT HOME

The District has established the following requirements and limitations to home education:

#### Participation in School

Students who are excused from attendance at school by reason of home education will be deemed to have withdrawn from enrollment in District schools during the period of home education. Therefore, the student is not eligible to participate in any of the District's pupil services, programs, or activities including, but not limited to:

- A. attendance at a District school on a part-time basis;
- B. participation in school-sponsored athletic programs or teams; (Ohio High School Athletic Association eligibility rules require that a student must attend the school in which s/he is enrolled before s/he can participate.)
- C. participation in school-sponsored co-curricular or extra-curricular activities or programs.

#### Re-Enrollment in School

If a parent wishes to have his/her child return to a District school, s/he must follow normal enrollment guidelines. The conditions described in AG <u>5463</u> - Student Transfer from a Nonaccredited School will apply.

In grades 9-12, if the student wishes to enroll, the parent must provide an academic assessment report for each class taken at home. In addition, the school will need the grades from the last public or private school attended. Athletic eligibility will be determined by OHSAA guidelines and District athletic policy.

Students are encouraged to enroll at the beginning of a semester.

All home-based, private education courses will be given a grade of P/F (Pass/Fail) and transcripts will denote "home-education, private education" with "P/F grades" and "credits" assigned.

The student's grade-point average will be established only after s/he has completed six (6) consecutive semesters of attendance at the high school. To be eligible for awards such as Valedictorian or Salutatorian, Distinguished Scholar, Ohio Academic Scholarship, National Honor Society, etc., the student must be enrolled for five (5) consecutive semesters prior to the second semester of the senior year.

If the student wishes to graduate, s/he must pass the 9th grade proficiency test and meet the requirements as specified in Board Policy <u>5460</u> and graduation guidelines.

# Defiance City School District Bylaws & Policies

### 5463 - CREDITS FROM STATE-CHARTERED, SPECIAL, AND NONCHARTERED SCHOOLS

In recognizing its responsibility to uphold the minimum educational standards of the State of Ohio, the Board of Education establishes the following policy and criteria regarding the acceptance of credits from nonpublic schools whether they be State-chartered, special, or nonchartered schools.

For credit or course-work to be accepted for courses taken in such schools, either a copy of the charter or other assurance of compliance with minimum requirements established by the State must be provided.

Recognition of credits or course-work shall be granted when the proper assurance and the student's transcript has been received. The District reserves the right to assess such transfer students in order to determine proper placement and to be assured the student can demonstrate the learnings which are prerequisite to a placement.

Although credits from nonchartered schools may be granted and placed on a student's transcript, no grades will be entered on the transcript or considered for class ranking. Only grades awarded for courses taken at the District or at a school approved or chartered by a State education agency shall be considered in class ranking and for entering on the transcript.

## **Home Education Notification Form**

3301-34-02 Statement of Purpose

The purpose of the rules in this chapter is to prescribe conditions governing the issuance of excuse from school attendance under section 3321.04 of the Revised Code, to provide for the consistent application thereof throughout the state by superintendents, and to safeguard the primary right of parents to provide the education for their child(ren). Home education must be in accordance with the law.
